| Program Length    | The typical exchange program is one academic semester, however, some students opt to study for two semesters (one year) if permitted by Chicago-Kent and by the student's home school. Nominated students should indicate on their application form their desired program length.   |
| Visa Requirements | Students who plan to complete the one semester exchange option will be provided an application form for the U.S. J-1 Student Exchange Visa, should they be admitted to the program. Those who plan to complete the full year will be issued an application form for the U.S. F-1 Student Visa.  |
| Health Insurance  | All international exchange students are required to purchase the IIT Student Health Insurance plan unless they can provide proof of health coverage from a U.S. health provider subject to the approval of the IIT Student Health Center. The estimated cost of this Health Insurance plan is \$994 USD for the one semester option and \$1800 USD for the full year. |
